# Clark School Board decides to go 2014 Farm and Home Show set with modified four-day schedule

The voice of Clark County since 1880

Two discussion items took up the majority of the public meeting portion of the January meeting of the Clark School Board Monday night. The two items dealt with potentially air conditioning the school (s) and the school calendar for the 2014-15 school year.

At the December board meeting, school board members requested the administration to put together three separate calendars, a fourday school week, a five-day school week and a modified four-day school week calendar, for them to discuss and choose from at this January

The consensus of the board was to adopt one of these three calendars and have the ability to 'tweak' the chosen calendar at a later date.

A healthy discussion ensued, as a handful of teachers were also in attendance and the board involved teacher input in the discussion.

Proposed legislation (by the state in the upcoming session), professional development (inservice), student help and ultimately what is best for student learning were all key areas of discussion.

is to go with a modified four-day schedule. Board members Kim Seefeldt, Bob Steffen, Amy Sass and Trudi Gaikowski all stated that they were leaning toward the modified four-day schedule and Todd Fjelland stated that he was sticking to his five-day vote.

Fjelland then asked about an after Labor Day start approach to the school year and superintendent Brian Heupel reiterated what he said a month ago, that because of ending the semester before Christmas as well as all schools in the co-op and the state for that matter, start during the third week of August, that it would be unrealistic and educational services would be lost.

Heupel ended this discussion talking about the importance of professional development and how this modified four-day schedule would allow for adequate professional development. This four-day calendar will be a negotiated agreement item, as it annually is, with the certified staff, so it is just a recommendation by the board, with the ability to make changes, as needed.

## The rural landscape continues to look newer - heading into 2014

The construction building numbers are in for 2013 and there was estimated \$6,644,889 on the books for construction in Clark County.

These numbers are approximations actually being on the low side, showing building estimation in the

Grain bins to the tune of \$4.3 million are being built or have been built in Clark County with a very large bin system on the Chris Lamb farm. Grain bins out number new houses and homes in the county this year with 23 bins not including the Lamb farm system and the six new seed storage bins at CK Seeds east of Clark.

In the city of Clark, \$273,600 worth of construction was within city limits with \$6,371,289 outside of the city of Clark.

Mayfield Truss added a \$450,000 addition to the west of their building and the Mayfield Colony added a pole building for grain storage. Silver Lake Colony is building a large warehouse addition and Fordham Colony has added a \$100,000 car wash. Hillcrest Colony will be adding a hog finishing barn and Collins Colony added a farrow to feeder operation.

Commercial improvements in 2013 were a \$1.1 million dollar fertilizer storage building still in construction just west of Clark by the Clark County Farmers Elevator. South Dakota Wheat Growers also added fertilizer storage at the Carpenter location.

Permits were taken out for Velocitel to put up a tower and shelter in Richland Township and a tower and radio room in Maydell Town-Central States Tower will have a cell tower in Richland Township and the Rural Tower Network company will have three GPS towers, one in Pleasant, one in Thorp and one in Elrod. A highway road surface camera was put up by Cliff Dekker's farm along US Highway 212 by the Garden City road.

Aaron Hemmingson put up a large retail sales building and Craig Spieker built a hangar at the Clark

Clark: This is a busy year for Clark as five municipal positions are open in 2014. The mayor's position, a three-year term, held by incumbent Larry Dreher is open this three-year council position. as well as council seats in Ward I, Ward II and Ward III.

In Ward I, Vicki Orris is the incumbent, in Ward II, Kerry Kline is the incumbent and in Ward III Lon Reidburn is the incumbent, all are for three-year terms. Also in Ward III is a one-year term up for election, currently held by Tony Woodland. Jackie Luttrell is the City of Clark finance officer.

Henry School: Henry School District #14-2 holds their election the same time as city elections. Tow three-year terms are open with the incumbents being Adam Hartley and Terry O'Neill. Dianne Easthouse is the business manager at Henry School. Clark and Willow Lake schools hold their school board elections in June.
