Winter weather will be noticeable by Veterans Day

Expect big weather changes this week, as snow and cold are in the

Meteorologists from the National Weather Service, Aberdeen, forecast the brunt of the wind, snow and cold to be west and north of Clark County, but the weather will be the story in South Dakota this week.

"North central South Dakota into North Dakota is the bull's eye for a blizzard event on Veterans Day, Fri-

day. At this time, it looks like Clark County will get a wintry mix of precipitation; rain on Wednesday and snow on Thursday into Friday."

"The northwest wind, with gusts in the 20 mph range, will determine what conditions exist, depending on where the snow is located."

"From Friday through next week, the high temperature each day will be in the mid-20s with lows in the single digits every night next

"On Thursday this week, it will be mostly cloudy, temperatures near freezing, windy; with a northeast wind between 24 and 31 mph, with gusts as high as 45 mph. It will remain windy throughout the night with temperatures in the lower teens."

The November council meeting is quite lengthy due to Board of Adjustment variances

The November meeting of the Clark City Council was on Monday, it began with discussion on 2023 salaries and progression of the raising of water rates, both in ordinance form. Council members heard the first reading of the 2023 salaries with little discussion.

The second reading of ordinance #578, regarding the water rate increase, was approved. The increase will raise water rates by 50¢ per 1,000 gallons from \$5.20 per 1,000 gallons to \$5.70 per 1,000 gallons, beginning in January 2023, for December 2022 billing. The rate increase is congruent with the Rural Water rate increase of 50¢. The board discussed the potential of yearly small increases to avoid a larger rate increase down the road.

Board of Adjustments

Jim Zeck was present requesting a variance to build a structure on his property that would violate the current setbacks. The potentially affected neighbor, Mario Guzman, was also present, requesting the setbacks that are currently in place remain in place. The board agreed that setbacks should remain as they are and Zeck will look at restructuring the size of his proposed build.

SGR Distributing owners Ray and Sara Gjerde were present to request variances for two potential properties. The first property located at the corner lot of 2nd Avenue Northwest and Clinton Street, is a proposed structure addition for personal use that would potentially be more than the allotted square mas party which is to be held at the footage for the property. Potentially affected neighbors, Tyler Helkenn and Chelsi Paulson, were present and expressed concern for water damage that could be caused by taking away too much of the ground and trees that currently pull the water from neighboring basements. This will be reapproached at a later date as the SGR Distributing will return to the drawing board with concerns in mind.

The second variance requested by SGR Distributing is for a duplex they will potentially build located on the corner lot of Dakota Street across from the elementary school and the ITC building. The lot size is small and the variance requested would allow more of the property to contain the dwelling. Neighbor to the east, Todd Fiedler, was present to express concern about the water run off and where it will be directed so as to not cause potential water damage on his neighboring property. This will also be reapproached at a later date, as SGR Properties will return to the drawing board again with concerns in mind.

Brandi Foster was present in request to open and operate a daycare in her home. Foster completed all requirements, including getting eight signatures from neighbors. All members approved her opening and operating the in-home daycare.

In Other Business:

* Board members discussed possible dates for this year's ChristClark Golf Course.

* Tara Thomas was present in regards to due accreditation for the library, which is to be completed December 2, 2022. In order to achieve accreditation, the library must have hours of operation that reflect an evening or weekend. At this time. the library will begin extended open hours on Thursday evenings. The hours will change from a 5:00 p.m.

closing to a 7:00 p.m. closing. * Darrin Alltflisch was present and spoke about the need for a new roof on Sanford Clinic Clark. The shingles were patched the last couple of times there was damage or leaking. Alltflisch proposed seeking bids for a tin roof with hopes to have the roof replaced this coming spring.
