



Wellnitz attends Chiefs of Police conference in Philadelphia, Pa.

Clark police chief Jeremy Wellnitz recently attended the 124th annual conference and exposition of the International Association of Chiefs of Police, in Philadelphia, Pa.

It was held at the Pennsylvania Convention Center in Philadelphia, from October 21-24. Officer Wellnitz applied for a scholarship to attend the conference and was selected to attend. Only four from South Dakota were chosen to attend this conference.

Wellnitz is the third vice president of the South Dakota Police Chiefs Association, a two year position he was elected to last fall.

Wellnitz was accompanied to Philadelphia on this trip by his fiancé Alaina Henning, who paid her own expenses. They went one day early and did some sightseeing.

Henning is a victim witness coordinator through the office of states attorneys and assists crime victims in 11 east central counties in South Dakota. Also enjoying history, she spent time touring Philadelphia's historic sites while Wellnitz attended the conference. The couple is planning a wedding for this spring.

There were 282 educational tracks to attend and eight were chosen out of those to fit in to Wellnitz' schedule over the four days.

"One goal of the conference is to network with others, learning what other agencies are doing - what's working and what's not" stated Wellnitz.

After the convention orientation, Wellnitz chose "The use of open source and social media to identify Actionable Intelligence in Investigations" for his first workshop. That was followed by: "How to get free access to mobile officer Investments to Your agency"; "Better Communication: The use of social media"; "Advancing 21st century Policing in smaller, rural and Tribal communities"; FBI director

Also during the conference was a 622 participant vendor fair - the largest vendor fair in the United States for law enforcement. Through this fair, Wellnitz acquired the state-of-the-art speed board company name which supplied the city's new speed board on North Smith Street.

Fourteen thousand officers, highway patrolmen and public safety official agency representatives attended this annual conference, (basically the administration of police

Clark homeowners to see similar tax amount in 2018

Some things are inevitable - like death and taxes. Every year taxes go up. The average home owner in Clark should expect to pay about the same in taxes in 2018 than he/she paid this year, according to figures compiled from the Clark County Auditor's office. (Depending on where one lives in Clark County, the amount one pays in taxes will differ and this story just shows figures for a city of Clark (homeowner) resident, regarding tax requests,

from 2017 into 2018. As the year progresses, hopefully more entities will be shown in Courier stories. Not all tax districts will mirror the city of Clark.)

The tax increase for 2018 is somewhat slight. The city, county and school district total is \$6,598,379.15, down from \$6,713,872.50 payable in 2017.

According to the auditor's office, most property (owner-occupied) will see a very slight increase, if any. If

the average home owner in Clark paid \$2,000 in taxes a year ago, that number will be quite close to that again this year.

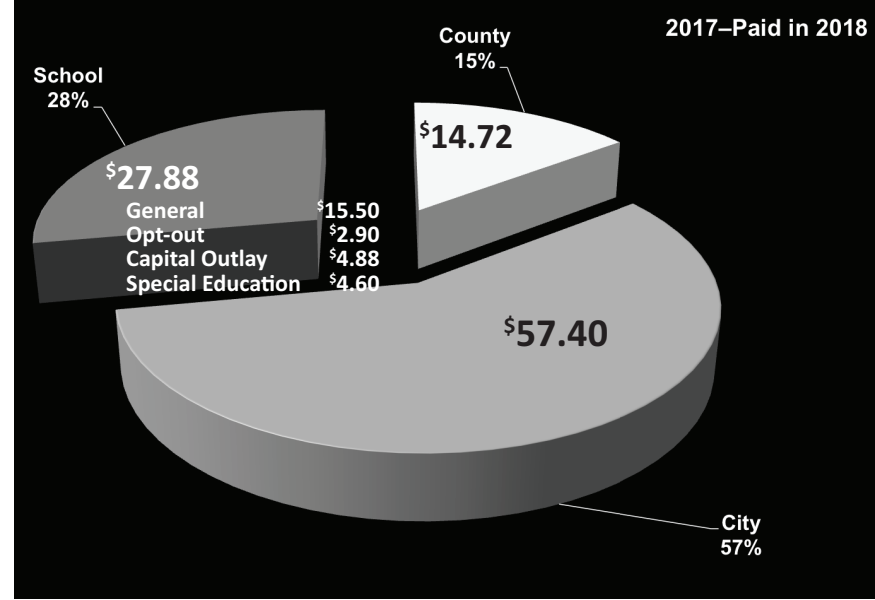
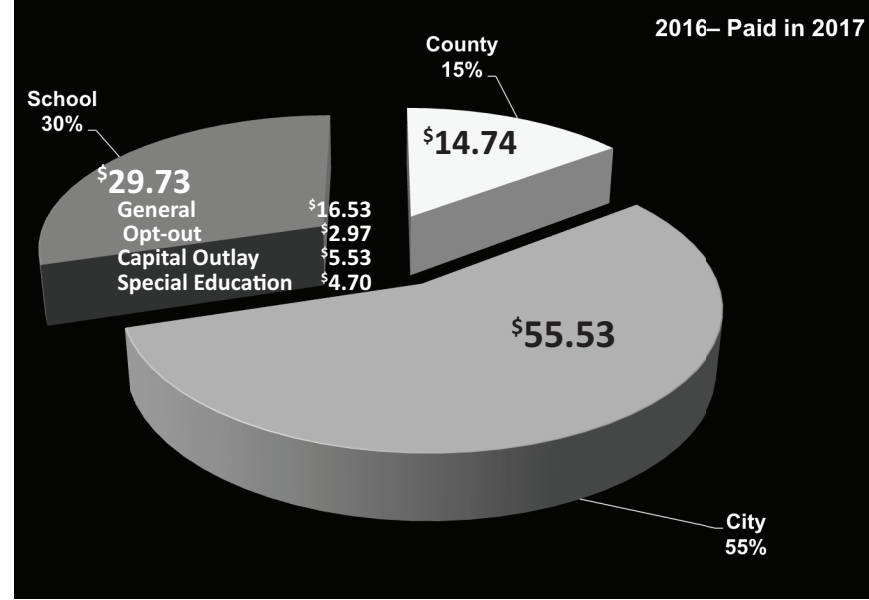
City requests constant

While property taxes are always on the increase, Clark finance officer Jackie Luttrell said that in her 15 years in this position that tax requests have remained constant and consistent. Municipal taxing districts rely on two factors, consumer price index (CPI) and growth, as to

what amount can be available for taxation. The city growth last year was 2.39, which is a positive number for a small community.

"As one looks at the pie charts - it looks funny and maybe a little skewed, percentage-wise, but one must remember this is specific to city residents. Any town (tax chart) will look like this," and the talk turned to what the city uses tax dol-

Here are the first six months of 2017 in review. Enjoy.

January

David Moritz, owner of Moritz Publishing in Clark has officially retired after a printing career spanning 50 years, most of it in Clark.

New elected officials take over at the Clark County Courthouse, including new commissioner Chris Sass. Violet Wicks is elected chairman of the Clark County Board of Commissioners.

Clark County Commissioners approve Vanguard Appraisals, an Iowa firm to reassess the parcels in Clark County, excluding bare ag land, in 2019-20.

Fire destroyed the machine shop and equipment it housed at Wulf Cattle (formerly Riverside Dairy) on New Years Eve. Wulf Cattle is a large feed lot located seven miles south of Raymond.

Brad and Laura McGirr of Creative Printing, Huron and Brookings opened Creative Printing, in Clark.

The City of Clark moves forward with the annexation process of the Big C Travel Plaza, which eventually became a reality.

\$10,510,365 was reportedly spent in 2016 construction in Clark County. 108 permits were issued.

February

Clark/Hamlin Cattlemen hold the 3rd Annual Pen Display in Willow Lake. Pen Display initiator Randy Nelson, Carpenter stated that Todd Wilkinson was the guest speaker.

Initiated Measure 22 was repealed by the State Legislature. IM 22 was passed by the people during the general election as an anti-corruption measure, but was actually a monster piece of legislation weighing in at 70 sections and more than 30 pages.

Michaela Flora, a senior at Clark High School served as a legislative page, sponsored by Sen. Brock Greenfield.



Henry School superintendent Steve Zirbel was honored as Outstanding Administrator recently at the State Student Council Convention in Rapid City. Additionally, Principal Phil Schonebaum was presented an award for Student Council Advisor of the Year.
