### S.D. Legislature overturns one of three Governor's vetoes on last session day

The Senate overturned one of the three vetoes from Gov. Dennis Daugaard and the House quickly concurred on the last day of the 2015 S.D. Legislative session in Pierre

The bill which successfully passed March 30 was SB 136, which had testimony from Sen. Xx Brown, R-Gettysburg, and no comments to uphold the veto. The bill seeks to correct a decision made by the Department of Revenue to apply sales tax on an amount already taxed on rural electric cooperatives.

their buildings, but it is different, said Brown, when it is taxed on the amount of electricity used by the consumer, which fluctuates.

Daugaard, in his letter to the Senate, had commented that he did not accept the argument that the current taxation system imposes a double tax. Rural electric companies, he said, are in a similar situation to thousands of businesses throughout South Dakota.

Rep. Thomas Brunner, R-Nisland, had noted that electric cooperatives did not have a problem with the tax

Cooperatives pay property tax on structure, just how it was imposed recently. It had been 20 years doing it the right way, he said, and now it has been done the wrong way.

The Senate passed the overturn by 31-1 with one person absent, and the House concurred by passing it 63-1, with six Representatives absent. The vote needed to be a twothirds majority.

The bill now becomes law without the Governor's signature.

This action authorizes up to a \$4 million grant for the city to build a wastewater treatment system. This new system will cost approximately \$7 million including land acquisition.

## Gov. Daugaard announces \$5.485 million for Clark Wastewater project

This week is a big week for the city of Clark going forward with the wastewater treatment system. On Monday, South Dakota Gov. Dennis Daugaard signed Senate Bill 173 into law.

Daugaard says by signing this law, the state Board of Water and Natural Resources has approved a \$5.485 million funding package to Clark for a new wastewater treatment facility.

The funding package includes a \$3 million Consolidated Water Facilities Construction Program grant and a \$2.485 million Clean Water terms are 3.25 percent for 30 years. The funds will be administered through the Department of Environment and Natural Resources. Clark finance officer Jackie Luttrell said she was very pleased about this week's activities and commented, "This funding gives us the opportunity to move forward on a problem we have been dealing with for almost five years now." "I am pleased to announce that Clark will receive this assistance," said Gov. Daugaard. "This funding will help Clark build a wastewater treatment facility to comply with new state discharge permit require-

ments.

Clark Mayor Larry Dreher stated that he was appreciative of all of the involved parties to give us this money and allow the city to gain compliance. "I'm glad it happened," stated the mayor, and then he was quick to understand that this also will be a burden financially to the residents of Clark with an increase in the water/sewer fees. "This is the avenue we've been forced into and we have a lot of work still ahead. but it will definitely be a positive for the city of Clark."

The project involves replacing State Revolving Fund loan. Loan Clark's existing mechanical waste- storm water and nonpoint source water treatment plant with a total retention facility. The change is necessary to assure Clark maintains compliance with the city's surface water discharge permit. Reclassification of lakes downstream from the existing treatment facility necessitates the construction of a total retention facility.

a \$1 million Consolidated Water Facilities Construction Program grant last year for the project.

The Consolidated Water Facilities Construction Program, funded in part by revenues from the sale of lotto tickets, provides grants and loans for water, wastewater and watershed projects. The Legislature appropriates Water and Environment Funds annually to the Consolidated program through the Governor's Omnibus Water Funding Bill. The Clean Water State Revolving Fund Program provides low-interest loans for wastewater,

If one enters the Lake Grocery Store in Willow Lake on Friday mornings between 8:30 a.m. and about 9:45 a.m. to 10:00 a.m., they will hear lively conversation and laughing in the back of the store.

There was talk around the table of maybe making the 'coffee shoppe' area bigger. "Maybe moving this wall behind us back a little, we've been talking about. We may need it," said Kathy Blocker.
