Informational meeting held regarding building plans at **Willow Lake School**

An informational meeting was held Tuesday evening at the Willow Lake School Board meeting, held in the Willow Lake auditorium. Approximately 40 people were in attendance, talking about the school's building plan, upgrading the older area of the school as well as constructing a new gymnasium.

The information portion of the board meeting began with Scott Sikkink, of HKG Architects, of Aberdeen, providing an updated summation of this building project. The meeting lasted approximately 90 minutes.

"Many, many people have been involved in this process since the strategic planning committee stage," began Sikkink and he noted that it is a fairly lengthy process, "but we are getting toward the fin-

Sikkink stated that the next step is that the board receives a set of drawings and then the bid process begins.

In January of this year the Willow Lake School Board approved this building project of renovating the 'old school area', including three classrooms and erecting a 13,762 square foot gym to be added south of the current auditorium. Since this January meeting, several significant changes to the building plan have been made. These changes were explained by Sikkink and are noted in the shaded box portion of this story.

During the question and answer session following Sikkink's remarks, as is often the case, it was

very dry year

As South Dakota transitions from April to May, warmer than average air and soil temperatures are prevalent throughout the state. However, spring precipitation has failed to appear across most of the state creating winter wheat and forage issues, explained Dennis Todey, SDSU Extension Climate Specialist & South Dakota State Climatolo-

"Lack of precipitation has led to a number of agricultural issues," said Todey. "If we don't receive adequate moisture in May, the issues could increase.

To clearly explain the climate outlook, Todey begins by taking a look back at the year-to-date condi-

A look back

April was very dry across most of South Dakota, with only a few weather locations to the west recording slightly above average precipitation. Total precipitation across the state ranged from 0.11-inches to just over 2-inches. The largest deficits were in the southeast where April was 2 inches or more below average, Todey said, referencing precipitation totals in Chamberlain, 0.41 inches; and Mellette, 0.11 inches; which ended with their driest April on record.

Madison, Roscoe, and Big Stone City recorded their second driest April on record, and another 11 weather stations recorded April 2015 among the top five driest on

"The dry situation has been a continuation of a weather pattern that set up in February, which resulted in longer term precipitation deficits," Todey said.

Records for low precipitation are much more apparent looking back for the year-to-date, explained Laura Edwards, SDSU Extension Climate Field Specialist.

She went on to say that as of Jan. 1, 2015 several weather stations in the middle of the state documented January 2015 as the driest on record including: De Smet, Forestburg, Murdo, Kennebec, Pierre, Wessington Springs, Madison and six others. "A few stations accumulated less than an inch of precipita-

2015 could be a City is beginning bid process for new clubhouse building

The top 'news' story coming out of Monday's May Clark City Council meeting is that the city of Clark is moving forward with 'new club-

house specs and bids'. In layman terms, the city is pursuing a new building, to be built to the east, or in front of the current Clark Municipal Golf Course club-

Clark finance officer Jackie Luttrell handed out floor plan diagrams of this potential 96' x 82' building which would face the #1 tee box. "If we are serious about this, we have to take the next step," said Luttrell, "and the next step is the bid process.

Clark mayor Larry Dreher said he looked at this from a community perspective and that there are many 'needs' on the long list, including a location large enough for gatherings, meetings and receptions.

"We looked at the most economical building type and we definitely want to involve our local workforce," said Dreher and he stated as far as how much this building would cost; "It's in the very preliminary stages,
