# **Garden City couple** killed in plane crash

A single-engine airplane crashed Sunday morning north of Groton, killing Doug and Tina Hansen of Garden City, according to the Furness Funeral Home notices on page four of the *Clark County Courier*.

The Groton Fly-In/Drive-In was last weekend with events that include airplane rides.

The crash occurred around 11:00 a.m. at the Groton Municipal Airport.

The plane was a 1997 American Champion 8KCAB fixed-wing, single-engine aircraft, according to information from the Federal Aviation Administration. It was registered to Doug Hansen.

The plane crashed under unknown circumstances near the runway, also according to FAA information.

Scott Meints, Brown County Emergency Management director, said the crash was related to activities at the air show.

The National Transportation Safety Board and Federal Aviation Administration had control of the scene and are investigating. The airport is about four miles north of Groton along State Highway 37.

Sunday's accident was the third fatal airplane crash in South Dakota this year, according to the National Transportation Safety Board.

Clark School Board, Monday, was loaded with newsworthy items, almost all COVID-19 related. By joint decision of the Clark-Willow Lake sports co-op and athletic

directors, local sporting events will not be open to the public, until an all clear is given. Tier 3 is now in effect regarding sports.

Tier 3 of the COVID athletic attendance policy limits only players and their parents to home contests until further notice. Only parents of students directly involved in the evenings' activities will be allowed to attend games. Siblings of players will not be allowed to attend. There will also be NO student population at these events and concession stands with limited service will be available.

This information has also been sent to the visiting teams.

The two schools are urging help in mitigating any possible spread of the COVID virus so that the Clark-Willow Lake Cyclones can return to "normal" spectator attendance at the games. Games will be

All school employees are deemed as essential workers to keep the school district operational throughout the school year. In order for these employees to have the opportunity to continue working in the school building even though they may be considered close contacts with one who has a positive test for COVID-19, the following requirements should be met:

• Employee must be tested for COVID-19 with a negative result prior to returning to school and continue to be symptom free.

• The employee must wear a mask or shield for at least the next 10 days in order to maintain safety for self and others.

• Regular hired staff are to be with students as much as possible for the benefit of educating them.

 $\star$  In order for someone to return to school after suspected illness without close contact, they must be symptom free for 24 hours, doctor clearance, OR negative results of COVID-19 testing.

 $\star$  Students or employees must remain away from school or school activities until COVID test results are made available. In the event that the health care professional has deemed it necessary to be tested, you must stay home until test results are in.

 $\star$  The school district will provide weekly COVID updates pertaining to school on webpage and will keep board members and stake-holders informed as to staff and student issues

## **Grand Jury indicts Brooks on drug charges**

On August 24, 2020, the Clark for September 21, in Clark. Each County Grand Jury indicted Clinton Brooks, age 41, of Clark, South Dakota, on two counts of Distribution of a Controlled Substance (Methamphetamine) in connection with alleged distribution that occurred in June of 2020.

According to Clark County State's Attorney Chad Fjelland, Brooks turned himself in to authorities on August 28 and his Initial Appearance in Circuit Court is scheduled count of Distribution of a Controlled Substance carries a maximum penalty of 10 years in the state penitentiary, a \$20,000 fine, or both such fine and imprisonment.

Additionally, Brooks is also currently charged with Possession of a Controlled Substance (Methamphetamine) and faces revocation proceedings related an earlier Possession of a Controlled Substance sentence.
